#### Application Rates:

LIGHT:	3.0 lbs/1,000 sq. ft.
LOW:	4.0 lbs/1,000 sq. ft.
MEDIUM:	5.0 lbs/1,000 sq. ft.
HIGH:	6.0 lbs/1,000 sq. ft.

#### For all applications:

- Apply to dry foliage.
- Water in after application with a minimum of 0.2 inches to help move particles into the turf canopy.
- Do not collect clippings for at least one mowing following application to avoid particle pick-up.

#### Cool Season Grasses:

- Apply at the LOW or MEDIUM RATE.
- Apply at the LIGHT RATE when temperatures exceed 85°F.

#### Warm Season Grasses:

- Apply at the LOW to HIGH RATE every 4-6 weeks during the period of active growth.

#### STORAGE AND USE

Store in a clean, dry place.  
Reseal opened bag by folding top down and securing.  
Use only in clean, dry spreaders.  
Do not leave unused product in spreaders.
