The Andersons Turf Products 5-0-31 provides grass with nitrogen and potash for maintaining strong, vigorous turf.

The nitrogen in this product is both readily and slowly available which makes this product excellent for applications throughout the growing season when the minimum soil temperatures are greater than 55°F to 60°F and not exceeding 85°F.

This product is dust free and free flowing. The uniform particle sizing assures easy and accurate applications.

Apply only as directed. Apply during the growing season.

For all applications:

- Apply at the LOW RATE when temperatures exceed 85°F.
